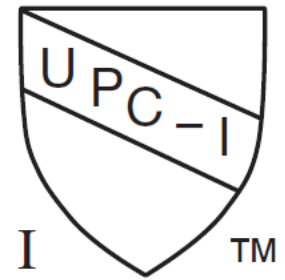

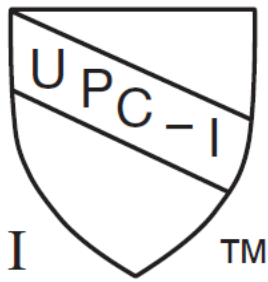
CHARACTERISTICS:

For valves equipped with a vacuum breaker, the critical level marking is to be at least six inches above the flood level rim of a water closet or the highest point of a urinal. 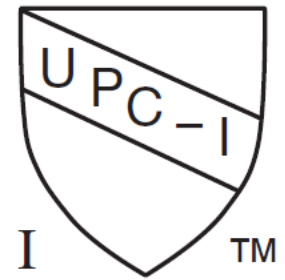
